 20 **DEBTOR’S CHAPTER 11 PLAN OF REORGANIZATION DATED JULY 15, 2022**

21 **PLEASE TAKE NOTICE** that a hearing will be held on **September 1, 2022 at 9:30 a.m.**
 22 before the Honorable August Landis, Chief United States Bankruptcy Judge, in his Courtroom 1
 23 located at 300 Las Vegas Blvd. South, Las Vegas, Nevada 89101, via ZoomGov, for the Court to
 24 consider the adequacy of the disclosure statement describing the chapter 11 plan of reorganization
 25 filed by Front Sight Management LLC, the chapter 11 debtor in possession herein [the “Debtor”].
 26

27 **PLEASE TAKE FURTHER NOTICE** that on July 15, 2022, the Debtor filed an initial
 28 version of its chapter 11 plan of reorganization [ECF No. 270] (the “Plan”) and an initial version of

1 its accompanying disclosure statement [ECF No. 271] (the “Disclosure Statement”). Because the
2 Debtor is in the process of (i) negotiating with various creditors and parties in interest as to various
3 terms of the Plan and Disclosure Statement, and (ii) finalizing membership terms for its business
4 going forward, the Debtor will file an amended Plan and an amended Disclosure on or before August
5 4, 2022 that includes more detailed information and financial projections.

6 **PLEASE TAKE FURTHER NOTICE THAT** copies of the Plan and Disclosure Statement
7 (and any amendments thereto) may be obtained from the above-captioned Court, located at the Foley
8 Federal Building, 300 Las Vegas Blvd. South, Las Vegas, Nevada 89101, through the Court’s
9 electronic filing system (<https://ecf.nvb.uscourts.gov/>), for free via the Debtor’s noticing agent at
10 <https://cases.stretto.com/FrontSight> or by sending a written request to counsel for the Debtor, Susan
11 K. Seflin, via email at sseflin@bg.law. Any opposition must be filed pursuant to Local Rule
12 9014(d)(1) on or before **August 18, 2022**. Hearing information may be obtained at

15 If you object to the relief requested, you *must* file a **WRITTEN** response to the adequacy of
16 the Disclosure Statement with the Court. You *must* also serve your written response on the
17 person who sent you this notice.

18 If you do not file a written response with the Court, or if you do not serve your written
19 response on the person who sent you this notice, then:

- 20 • The Court may *refuse to allow you to speak* at the scheduled hearing; and
- 21 • The Court may *rule against you* without formally calling the matter at the hearing.
