9 support of the Employment Applications may be filed on July 22, 2022 or presented orally
10 at the hearing. The relief requested herein may be granted without a hearing if a timely objection is
11 not filed and served as required by Local Rule 9014(b)(1)(D).

12 If you object to the relief requested, you *must* file a WRITTEN response to this
13 pleading with the court. You *must* also serve your written response on the person
14 who sent you this notice. If you do not file a written response with the court, or if
15 you do not serve your written response on the person who sent you this notice
16 then:

- 17 ● The court *may refuse to allow you to speak* at the scheduled hearing; and
- 18 ● The court *may rule against you* without formally calling the matter at
19 the hearing.

20 **NOTICE IS FURTHER GIVEN** that pursuant to Administrative Order 2020-14, all
21 hearings are currently being held remotely unless otherwise ordered by the Court. The hearing on
22 the Employment Applications will be held remotely via Zoom. To connect to a hearing by Zoom,
