25 NOTICE IS HEREBY GIVEN that the *Motion for Reconsideration Pursuant to Federal*
 26 *Rule of Civil Procedure 54(b)* (the "Motion")¹ was filed on July 18, 2022 by Dr. Ignatius Piazza

1 (“Dr. Piazza”), Jennifer Piazza (“Jennifer”), VNV Dynasty Trust I, and VNV Dynasty Trust II
2 (collectively, the “Trusts”, and with Dr. and Jennifer Piazza, the “Movants”) in the above-
3 captioned case. The Motion seeks the following relief: Movants request, to the extent not
4 determined to be void as entered in violation of the automatic stay, that the Court reconsider the
5 Sanctions Order pursuant to Fed. R. Civ. P. 54 as made applicable to these proceedings pursuant
6 to Fed. R. Bank. P. 7054, in the above-referenced adversary proceeding. Any opposition must be
7 filed pursuant to Local Rule 9014(d)(1).

8 NOTICE IS FURTHER GIVEN that if you do not want the court to grant the relief sought
9 in the Motion, or if you want the court to consider your views on the Motion, then you must file
10 an opposition with the court, and serve a copy on the person making the Motion *no later than 14*
11 *days* preceding the hearing date for the Motion, unless an exception applies (see Local Rule
12 9014(d)(3)). The opposition must state your position, set forth all relevant facts and legal authority,
13 and be supported by affidavits or declarations that conform to Local rule 9014(c).

14 If you object to the relief requested, you *must* file a **WRITTEN** response to this
15 pleading with the court. You *must* also serve your written response on the person
who sent you this notice.

16 If you do not file a written response with the court, or if you do not serve your
17 written response on the person who sent you this notice, then:

- 18 • The court may *refuse to allow you to speak* at the scheduled hearing; and
- 19 • The court may *rule against you* without formally calling the matter at the
20 hearing.
