10 to continue the Motion to Quash to September 30, 2022 at 9:30 a.m., for status only. It is the Parties’  
11 intent that prior to such continued hearing, the Parties will attempt to resolve outstanding issues on  
12 the Motion to Quash and further report back to the Court on the status.
