**DECLARATION OF JAMES HARRISS IN SUPPORT OF CLAIMANT 217'S  
RESPONSE TO DEBTOR'S FIRST OMNIBUS OBJECTION (1) REDUCING AND  
ALLOWING CERTAIN MEMBER CLAIMS AND (2) DISALLOWING AND  
EXPUNGING CERTAIN OTHER MEMBER CLAIMS; CLAIMANT 217'S MOTION  
TO ALLOW COUNTING OF BALLOT UNDER RULE 3018(a)**

3. After reviewing the Debtor's *First Omnibus Objection (1) Reducing and Allowing Certain Member Claims and (2) Disallowing and Expunging Certain Other Member Claims* ("**Debtor's Objection**"), I am of the belief that the primary objection raised
