**ORDER APPROVING STIPULATION RESOLVING THE DEBTOR’S SIXTH OMNIBUS  
OBJECTION AS IT RELATES TO CLAIM NOS. 213-1, 214-1, AND 529-1  
FILED BY WILLIAM FECZKO**

1 The Court, having reviewed the *Stipulation Resolving the Debtor’s Sixth Omnibus Objection*  
2 *as it Relates to Claims Nos. 213-1, 214-1, and 529-1* filed by William Feczko [ECF No. 579] (the  
3 “Stipulation”)<sup>1</sup> entered into between and among Front Sight Management LLC, the chapter 11  
4 debtor herein (the “Debtor”), and claimant William Feczko (“Claimant”), and good cause appearing  
5 therefor,

6 **IT IS HEREBY ORDERED:**

- 7 1. The Stipulation is approved in its entirety.
- 8 2. Claim 213 is allowed as a general unsecured claim in the amount of \$75,472.50 (the  
9 “Allowed Claim”).
- 10 3. Claim 214 and Claim 529 are disallowed in their entirety.
- 11 4. Except for the Allowed Claim and the right to enforce the Stipulation and the order  
12 approving the Stipulation, Claimant shall have no additional claim(s) against the Debtor or its estate  
13 arising from or relating to the facts alleged in Claim 213, Claim 214 or Claim 529.
- 14 5. To the extent that the Objection relates to in Claim 213, Claim 214 or Claim 529, it is  
15 resolved pursuant to this Stipulation.
- 16 6. Upon entry of this Order, Stretto, the claim and noticing agent appointed in the  
17 Debtor’s case, is directed to modify and update its database for this case to reflect that Claim 213 is  
18 allowed as a general unsecured claim in the amount of \$75,472.50 and that Claim 214 and Claim  
19 529 are disallowed in their entirety.
- 20 7. Upon entry of this Order, the Court clerk is directed to modify and update the claim  
21 register in this case to reflect an allowed amount of an \$75,472.50 general unsecured claim for Claim  
22 213 and that Claim 214 and Claim 529 are disallowed in their entirety.
- 23 8. This Court shall have the exclusive jurisdiction to interpret and enforce this  
24 Stipulation and this Order.

25 **IT IS SO ORDERED.**
