**ORDER GRANTING FINAL FEE APPLICATION OF
DUNDON ADVISERS LLC FOR COMPENSATION FOR SERVICES RENDERED AND
REIMBURSEMENT OF EXPENSES INCURRED AS FINANCIAL ADVISER TO THE
OFFICIAL COMMITTEE OF UNSECURED CREDITORS
OF FRONT SIGHT MANAGEMENT LLC FOR THE PERIOD
FROM JUNE 15, 2022 THROUGH AND INCLUDING DECEMBER 9, 2022**

1 The Court having held a hearing on January 9, 2023 at 9:30 a.m. (the “Hearing”) to consider
2 the *Final Fee Application of Dundon Advisers LLC for Compensation for Services Rendered and*
3 *Reimbursement of Expenses Incurred as Financial Adviser to the Official Committee of Front Sight*
4 *Management LLC for the Period from June 15, 2022 Through and Including December 9, 2022*
5 (the “Application”) [ECF No. 598],¹ with all appearances noted on the record at the time of the
6 Hearing; and the Court having reviewed the Application, and other related pleadings and papers on
7 file in the above-captioned bankruptcy case; and the Court finding that (a) it has jurisdiction over
8 this matter pursuant to 28 U.S.C. § 157; (b) that this proceeding is a core proceeding pursuant to
9 28 U.S.C. § 157(b)(2); (c) that venue of the Debtor’s chapter 11 case and the Application is proper
10 under 28 U.S.C. §§ 1408 and 1409; (d) that service and notice of the Application was sufficient
11 under the circumstances; and (e) that the legal and factual bases set forth in the Application establish
12 just cause for the relief granted herein; and the Court having made certain findings of fact and
13 conclusions of law on the record at the hearing, which are incorporated herein by reference pursuant
14 to Fed. R. Civ. P. 52, as made applicable pursuant to Fed. R. Bankr. P. 7052 and 9014; and the Court
15 noting that Dundon agreed to voluntary reduction of its fees in the amount of \$14,039.30 pursuant
16 to the *United States Trustee’s Notice of Voluntary Reduction in Fees with Respect to Dundon*
17 *Advisers, LLC’s Second and Final Fee Application* [ECF No. 618]; and noting that no opposition to
18 the Application having been filed; and the Court having determined that the relief requested in the
19 Application is appropriate; and for good cause appearing:

20 **IT IS HEREBY ORDERED** that the Application as modified is **APPROVED**.

21 **IT IS HEREBY FURTHER ORDERED** that the fee request contained within the
22 Application, as voluntarily reduced, is hereby approved on a final basis and allowed in the aggregate
23 amount of **\$254,396.70** (the “Final Award”) for the period of June 15, 2022 through
24 December 9, 2022 (the “Final Period”), consisting of fees in the amount of \$254,396.70 for the Final
25 Period.

26 **IT IS HEREBY FURTHER ORDERED** that upon entry of this Order, BG Law LLP (“BG
27 Law”), counsel to the Debtor during its chapter 11 bankruptcy case, is instructed to pay from the

1 professional fee reserve maintained by BG Law pursuant to the confirmation order \$140,229.70 to
2 Dundon, which are the unpaid fees for the Final Period as allowed by the Court.
