ORDER APPROVING STIPULATION RESOLVING EIGHTH OMNIBUS OBJECTION AS IT RELATES TO CLAIM 1015-1 FILED BY DAEDALIAN TECHNOLOGIES, LTD.

The Court, having reviewed the *Stipulation Resolving Eighth Omnibus Objection as it Relates to Claim 1015-1 filed by Daedalian Technologies, Ltd.* [ECF No. 788] (the “Stipulation”)¹

1 entered into between and among Province, LLC, solely in its capacity as the duly authorized and
2 acting Liquidating Trustee (the “Liquidating Trustee”) of the Front Sight Creditors Trust (the
3 “Liquidating Trust”), and claimant Daedalian Technologies, Ltd. (“Claimant”), and good cause
4 appearing therefor,

5 **IT IS HEREBY ORDERED:**

6 1. The Stipulation is approved in its entirety.

7 2. Claim 1015 is allowed as a general unsecured claim in the amount of \$9,851.00 (the
8 “Allowed Claim”) and disallowed to the extent that it asserts any amount over \$9,851.00.

9 3. Except for the Allowed Claim and the right to enforce the Stipulation and the order
10 approving the Stipulation, Claimant shall have no additional claim(s) against the Debtor, its estate,
11 the Liquidating Trust or the Liquidating Trustee arising from or relating to the facts alleged in Claim
12 1015.

13 4. To the extent that the 8th Omnibus Objection relates to Claim 1015, it is resolved
14 pursuant to this Stipulation.

15 5. Upon entry of this Order, the Court clerk is directed to modify and update the claim
16 register in this case to reflect an allowed amount of a \$9,851.00 general unsecured claim for Claim
17 1015.

18 6. This Court shall have the exclusive jurisdiction to interpret and enforce this
19 Stipulation and this Order.

20 **IT IS SO ORDERED.**
