ORDER APPROVING STIPULATION RESOLVING NINTH OMNIBUS OBJECTION AS IT RELATES TO CLAIM 338-1 FILED BY MATTHEW LEE BALDWIN

The Court, having reviewed the *Stipulation Resolving Ninth Omnibus Objection as it Relates to Claim 338-1 filed by Matthew Lee Baldwin* [ECF No. 795] (the “Stipulation”)¹ entered into

1 between and among Province, LLC, solely in its capacity as the duly authorized and acting
2 Liquidating Trustee (the “Liquidating Trustee”) of the Front Sight Creditors Trust (the “Liquidating
3 Trust”), and claimant Matthew Lee Baldwin (“Claimant”), and good cause appearing therefor,

4 **IT IS HEREBY ORDERED:**

5 1. The Stipulation is approved in its entirety.

6 2. Claim 338 is allowed as a general unsecured claim in the amount of \$299.00 (the
7 “Allowed Claim”) and disallowed to the extent that it asserts an amount over \$299.00.

8 3. Except for the Allowed Claim and the right to enforce the Stipulation and the order
9 approving the Stipulation, Claimant shall have no additional claim(s) against the Debtor, its estate,
10 the Liquidating Trust or the Liquidating Trustee arising from or relating to the facts alleged in Claim
11 338.

12 4. To the extent that the 9th Omnibus Objection relates to Claim 338, it is resolved
13 pursuant to this Stipulation.

14 5. Upon entry of this Order, the Court clerk is directed to modify and update the claim
15 register in this case to reflect an allowed amount of a \$299.00 general unsecured claim for Claim
16 338.

17 6. This Court shall have the exclusive jurisdiction to interpret and enforce this
18 Stipulation and this Order.
