1 **NOTICE IS FURTHER GIVEN** that if you do not want the Court to grant the relief sought
2 in the Omnibus Objection, or if you want the Court to consider your views on the Omnibus
3 Objection, then you must file an opposition with the Court, and serve a copy on the person making
4 the Omnibus Objection **no later than 14 days** preceding the hearing date for the Omnibus
5 Objection, unless an exception applies (*see* Local Rule 9014(d)(3)).

7 If you object to the relief requested, you *must* file a **WRITTEN** response to the Omnibus
8 Objection with the Court. You *must* also serve your written response on the person who sent
9 you this notice.

10 If you do not file a written response with the Court, or if you do not serve your written
11 response on the person who sent you this notice, then:

- 12 • The Court may *refuse to allow you to speak* at the scheduled hearing; and
- 13 • The Court may *rule against you* without formally calling the matter at the hearing.
