14 Rule 9014(c), and (iii) must be filed with the Court no later than **14 days before the hearing, i.e. by**
15 **July 2, 2024.**

16 **NOTICE IS FURTHER GIVEN** that if you do not want the Court to grant the relief sought
17 in the Motion, or if you want the Court to consider your views on the Motion, then you must file an
18 opposition with the Court, and serve a copy on the person making the Motion **no later than 14 days**
19 **preceding the hearing date for the Motion, unless an exception applies** (*see* Local Rule 9014(d)(3)).
